## A BILL

To amend the SUPPORT for Patients and Communities Act to reauthorize a program to support individuals in substance use disorder treatment and recovery to live independently and participate in the workforce, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Comprehensive Addic-
- 5 tion Recovery through Effective Employment and Reentry
- 6 Act of 2023" or the "CAREER Act of 2023".

1	SEC. 2. TREATMENT, RECOVERY, AND WORKFORCE SUP-
2	PORT GRANTS.
3	Section 7183 of the SUPPORT for Patients and
4	Communities Act (42 U.S.C. 290ee–8) is amended—
5	(1) in subsection (b), by inserting "each" before
6	"for a period";
7	(2) by amending subsection $(c)(2)$ to read as
8	follows:
9	"(2) Rates.—The rates described in this para-
10	graph are the following:
11	"(A) The amount by which the average
12	rate of drug overdose deaths in the State, ad-
13	justed for age, for the period of 5 calendar
14	years for which there is available data, includ-
15	ing if necessary provisional data, immediately
16	preceding the grant cycle (which shall be the
17	period of calendar years 2018 through 2022 for
18	the first grant cycle following the enactment of
19	the Comprehensive Addiction Recovery through

22	mortality rate, as determined by the Director of

9	(C) by striking "An entity" and inserting
10	the following:
11	"(1) In general.—An entity"; and
12	(D) by adding at the end the following:
13	"(2) Transportation services.—An entity
14	receiving a grant under this section may use the
15	funds for providing transportation for individuals to
16	participate in an activity supported by a grant under
17	this section, which transportation shall be to or from
18	a place of work or a place where the individual is re-
19	ceiving vocational education or job training services
20	or receiving services directly linked to treatment of
21	or recovery from a substance use disorder.";

10	(5) in subsection (k), by striking "\$5,000,000
11	for each of fiscal years 2019 through 2023" and in-
12	serting "\$12,000,000 for each of fiscal years 2024
13	through 2028".
