4	quire psychiatric hospitals (as defined in section 1861(f)
5	of the Social Security Act (42 U.S.C. 1395x(f))) to report
6	to State agencies on incidents within such hospitals that
7	result in injury or death in order to encourage and facili-
8	tate State efforts to inform the Federal Government and
9	the public about the frequency, nature, and severity of
10	such incidents.
11	(b) Reporting Requirement.—
12	(1) In general.—A psychiatric hospital (as
13	defined in section 1861(f) of the Social Security Act
14	(42 U.S.C. 1395x(f))) located in a State shall, as a
15	condition of receiving any Federal funds or other
16	Federal support, submit to the appropriate agency
17	of such State a daily report that details any inci-
18	dents that resulted, on the date that is one day prior

2	the injury or death of a patient or staff member of

4	(2) Construction.—Paragraph (1) shall be
5	construed as requiring such a psychiatric hospital to
6	so submit such daily report regardless of whether

such an incident occurred on the date that is one

day prior to the date on which the report is so sub-

mitted.

8	the Secretary of Health and Human Services shall apply
9	paragraph (5) of such section in a manner that requires,
10	in the case that an applicable individual requests that a
11	disclosure described in such paragraph be made with re-
12	spect to an individual described in such paragraph, that
13	such disclosure be made.
14	(b) Applicable Individual Defined.—For pur-
15	poses of subsection (a), the term "applicable individual"
16	means, with respect to an individual described in such
17	paragraph (5), a family member or other person identified
18	in paragraph (1) of such section 164.510(b) who was in-
