COMMITTEE ON ENERGY AND COMMERCE -- 115TH CONGRESS ROLL CALL VOTE # 6

BILL: Resolution to adopt the authorization and oversight plan of the Committee on Energy and Commerce for the 115th Congress

AMENDMENT: An en bloc amendment offered by Ms. Castor, No. 2, to provide that the Committee will examine the effects of climate change on human health, including but not limited to the impact of climate change on vector-borne diseases, respiratory and cardiovascular impacts, heat exposure, water-related illnesses, and food safety; the Committee will also examine actions needed to promote the health of individuals in vulnerable populations and communities that will disproportionately bear the health burdens of climate change; shall investigate any efforts by the Trump administration to ignore or obfuscate climate science, intimidate climate scientists, or extinguish climate data; will examine ways to ensure that scientific decisions by the Administration reflect the studies and conclusions of independent scientists, not just science backed by regulated entities; in recognition of the threat that climate change poses to our national security, will examine activities undertaken by the Federal government in coordination with the defense community to mitigate climate change, strengthen resiliency, and promote domestic energy security; will hold hearings to examine each of the multiple lines of evidence that convince the overwhelming majority of scientists and scientific organizations that climate change is occurring, is caused by human activities, and poses substantial risks to the nation's public health, environment, economy, and prosperity; and invited witnesses will include representatives from the National Academy of Sciences, the National Science Foundation, the Department of Energy National Laboratories, relevant federal agencies, and the Intergovernmental Panel on Climate Change.

DISPOSITION: NOT AGREED TO, by a roll call vote of 21 yeas and 29 nays.
