Page 2, line 19, strike “personal”.

Strike “data in electronic form” each place it appears and insert “information in electronic form”.

Page 11, line 19, strike “data” and insert “information”.

Page 11, line 21, strike “data” and insert “information”.

Page 19, line 11, strike “DATA IN ELECTRONIC FORM” and insert “INFORMATION IN ELECTRONIC FORM”.

Page 19, line 22, strike “data” and insert “information”.

Page 19, line 24, strike “data” and insert “information”.

Page 21, strike line 24 and all that follows through page 22, line 3, and insert the following (and redesignate subsequent provisions accordingly):

1 (B) ADDITIONAL INFORMATION.—The
2 term “personal information” also includes—

3 (i) in the case of information in elec-
4 tronic form maintained by a telecommuni-
5 cations carrier or a provider of inter-
6 connected VoIP service—

7 (I) proprietary information of,
8 and relating to, other telecommuni-
9 cations carriers or providers of inter-
10 connected VoIP service, equipment
11 manufacturers, and customers, includ-
12 ing telecommunications carriers or
13 providers of interconnected VoIP serv-
14 ice reselling telecommunications serv-
15 ices or interconnected VoIP services
16 provided by a telecommunications car-
17 rier or provider of interconnected
18 VoIP service; and

19 (II) information that relates to
20 the quantity, technical configuration,
21 type, destination, location, and
22 amount of use of a telecommuni-
23 cations service or interconnected VoIP
24 service subscribed to by any customer
25 of a telecommunications carrier or

1 provider of interconnected VoIP serv-
2 ice, and that is made available to the
3 carrier or provider by the customer
4 solely by virtue of the carrier-cus-
5 tomer or provider-customer relation-
6 ship, and information contained in the
7 bills pertaining to telephone exchange
8 service, telephone toll service, or inter-
9 connected VoIP service received by a
10 customer of a telecommunications car-
11 rier or provider of interconnected
12 VoIP service; and

13 (ii) in the case of information in elec-
14 tronic form maintained by a cable operator
15 or satellite carrier, personally identifiable
16 information concerning any subscriber to a
17 cable service, satellite service, or any other
18 wire or radio communications service pro-
19 vided using any of the facilities of the
20 cable operator or satellite carrier that are
21 used in the provision of cable or satellite
22 service, including the extent of any viewing
23 or other use by the subscriber of a cable or
24 satellite service or other service provided
25 by the cable operator or satellite carrier,

1 the nature of any transaction made by the
2 subscriber over the cable or satellite system
3 of the cable operator or satellite carrier, or
4 records revealing cable or satellite sub-
5 scriber selection of video programing from
6 a cable operator or satellite carrier.
