Add at the end of title III the following subtitle:

7	(a) Negotiation by Secretary.—Section 1860D—
8	11 of the Social Security Act (42 U.S.C. 1395w-111) is
9	amended by striking subsection (i) (relating to noninter-
10	ference) and inserting the following:
11	"(i) Negotiation of Lower Drug Prices.—
12	"(1) In General.—Notwithstanding any other
13	provision of law, the Secretary shall negotiate with
14	pharmaceutical manufacturers the prices (including
15	discounts, rebates, and other price concessions) that
16	may be charged to PDP sponsors and MA organiza-
17	tions for covered part D drugs for part D eligible in-
18	dividuals who are enrolled under a prescription drug
19	plan or under an MA-PD plan.

1	"(2) NO CHANGE IN RULES FOR
2	FORMULARIES.—
3	"(A) In general.—Nothing in paragraph
4	(1) shall be construed to authorize the Sec-
5	retary to establish or require a particular for-
6	mulary.
7	"(B) Construction.—Subparagraph (A)
8	shall not be construed as affecting the Sec-
9	retary's authority to ensure appropriate and
10	adequate access to covered part D drugs under
11	prescription drug plans and under MA-PD
12	plans, including compliance of such plans with
13	formulary requirements under section 1860D-
14	4(b)(3).
15	"(3) Construction.—Nothing in this sub-
16	section shall be construed as preventing the sponsor
17	of a prescription drug plan, or an organization offer-
18	ing an MA-PD plan, from obtaining a discount or
19	reduction of the price for a covered part D drug
20	below the price negotiated under paragraph (1).
21	"(4) Semi-annual reports to congress.—
22	Not later than June 1, 2016, and every 6 months
23	thereafter, the Secretary shall submit to the Com-
24	mittees on Ways and Means, Energy and Commerce,
25	and Oversight and Government Reform of the House

of Representatives and the Committee on Finance of 1 2 the Senate a report on negotiations conducted by the 3 Secretary to achieve lower prices for Medicare beneficiaries, and the prices and price discounts achieved 4 by the Secretary as a result of such negotiations.". 5 (b) Effective Date.—The amendment made by 6 7 subsection (a) shall take effect on the date of the enactment of this Act and shall first apply to negotiations and 8 prices for plan years beginning on January 1, 2016.
