Strike all after the enacting clause and insert the following:

1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "National Suicide Hot-
3	line Improvement Act of 2018".
4	SEC. 2. DEFINITIONS.
5	In this Act—
6	(1) the term "Commission" means the Federal
7	Communications Commission;
8	(2) the term "covered dialing code" means a
9	simple, easy-to-remember, 3-digit dialing code; and
10	(3) the term "N11 dialing code" means an ab-
11	breviated dialing code consisting of 3 digits, of
12	which—
13	(A) the first digit may be any digit other
14	than "1" or "0"; and
15	(B) each of the last 2 digits is "1".
16	SEC. 3. STUDIES AND REPORTS.
17	(a) Primary Study.—

1	(1) In General.—The Commission, in coordi-
2	nation with the Assistant Secretary for Mental
3	Health and Substance Use and the Secretary of Vet-
4	erans Affairs, shall conduct a study that—
5	(A) examines the feasibility of designating
6	an N11 dialing code or other covered dialing
7	code to be used for a national suicide preven-
8	tion and mental health crisis hotline system;
9	and
10	(B) analyzes the effectiveness of the Na-
11	tional Suicide Prevention Lifeline as of the date
12	on which the study is initiated, including how
13	well the lifeline is working to address the needs
14	of veterans.
15	(2) Requirements.—
16	(A) Commission.—In conducting the
17	study under paragraph (1), the Commission
18	shall—
19	(i) consider—
20	(I) each of the N11 dialing codes,
21	including the codes that are used for
22	other purposes; and
23	(II) other covered dialing codes;
24	(ii) consult with the North American
25	Numbering Council; and

1	(iii) review the information provided
2	by the Assistant Secretary for Mental
3	Health and Substance Use and the Sec-
4	retary of Veterans Affairs under subpara-
5	graphs (B) and (C), respectively, of this
6	paragraph.
7	(B) SAMHSA STUDY AND REPORT TO AS-
8	SIST COMMISSION.—To assist the Commission
9	in conducting the study under paragraph (1),
10	the Assistant Secretary for Mental Health and
11	Substance Use shall analyze and, not later than
12	180 days after the date of enactment of this
13	Act, report to the Commission on—
14	(i) the potential impact of the des-
15	ignation of an N11 dialing code, or other
16	covered dialing code, for a suicide preven-
17	tion and mental health crisis hotline sys-
18	tem on—
19	(I) suicide prevention;
20	(II) crisis services; and
21	(III) other suicide prevention and
22	mental health crisis hotlines, includ-
23	ing—
24	(aa) the National Suicide
25	Prevention Lifeline; and

1	(bb) the Veterans Crisis
2	Line; and
3	(ii) possible recommendations for im-
4	proving the National Suicide Prevention
5	Lifeline generally, which may include—
6	(I) increased public education
7	and awareness; and
8	(II) improved infrastructure and
9	operations.
10	(C) VA STUDY AND REPORT TO ASSIST
11	COMMISSION.—To assist the Commission in
12	conducting the study under paragraph (1), the
13	Secretary of Veterans Affairs shall study and,
14	not later than 180 days after the date of enact-
15	ment of this Act, report to the Commission on
16	how well the National Suicide Prevention Life-
17	line and the Veterans Crisis Line, as in effect
18	on the date on which the study is initiated, is
19	working to address the needs of veterans.
20	(b) Primary Commission Report.—
21	(1) In general.—Not later than 1 year after
22	the date of enactment of this Act, the Commission,
23	in coordination with the Assistant Secretary for
24	Mental Health and Substance Use and the Secretary
25	of Veterans Affairs, shall submit a report on the

1	study conducted under subsection (a) that rec-
2	ommends whether a particular N11 dialing code or
3	other covered dialing code should be used for a na-
4	tional suicide prevention and mental health crisis
5	hotline system to—
6	(A) the Committee on Commerce, Science,
7	and Transportation of the Senate;
8	(B) the Committee on Health, Education,
9	Labor, and Pensions of the Senate; and
10	(C) the Committee on Energy and Com-
11	merce of the House of Representatives.
12	(2) Additional contents.—If the report sub-
13	mitted by the Commission under paragraph (1) rec-
14	ommends that a dialing code should be used, the re-
15	port shall also—
16	(A) outline the logistics of designating
17	such a dialing code;
18	(B) estimate the costs associated with des-
19	ignating such a dialing code, including—
20	(i) the costs incurred by service pro-
21	viders, including—
22	(I) translation changes in the
23	network; and
24	(II) cell site analysis and re-
25	programming by wireless carriers; and

1	(ii) the costs incurred by States and
2	localities;
3	(C) provide recommendations for desig-
4	nating such a dialing code;
5	(D) provide a cost-benefit analysis com-
6	paring the recommended dialing code with the
7	National Suicide Prevention Lifeline, as in ef-
8	fect on the date on which the report is sub-
9	mitted; and
10	(E) make other recommendations, as ap-
11	propriate, for improving the National Suicide
12	Prevention Lifeline generally, which may in-
13	clude—
14	(i) increased public education and
15	awareness; and
16	(ii) improved infrastructure and oper-
17	ations.
