5 "(1) LIMITATION ON FEDERAL FINANCIAL PAR-6 TICIPATION.—Notwithstanding any other provision 7 of this title, to be eligible for federal financial par-8 ticipation under this title for expenses incurred as 9 medical assistance or as an administrative expense 10 for nonemergency transportation to medically nec-11 essary services described in subsection (a)(30), the 12 State Medicaid agency of such State must have in 13 place a prior authorization or utilization manage-14 ment requirement for such services.

15 "(2) PRIOR AUTHORIZATION DEFINED.—For 16 purposes of paragraph (1), the term 'prior author-17 ization' means a process through which a request for 18 provisional affirmation of coverage is submitted for 19 review before the service involved is furnished and 20 before a claim is submitted for payment for such 21 service.".

(c) EFFECTIVE DATE.—The amendments made bythis section shall take effect on the date of the enactment
