## **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Enhancing Broad5 caster Diversity and Inclusion by Verifying and Ensuring
6 the Reporting required by Statute Is Transpiring and

Yielding Data Act" or the "Enhancing Broadcaster DI VERSITY Data Act".

## **3 SEC. 2. OWNERSHIP AND DIVERSITY REPORTING.**

4 (a) SENSE OF CONGRESS.—Recognizing the long his-5 tory of exclusion of women and people of color from media resources in the United States, and the responsibility of 6 7 broadcasters to be responsive to the needs and interests 8 of their communities of license, it is the sense of Congress 9 that the Commission should carry out policies promoting 10 diversity, localism, and inclusion in the broadcast and cable industries. As such, Congress directs the Commis-11 12 sion to take the actions described in subsection (b) and the amendments made by such subsection. 13

14 (b) Media Ownership and Diversity.—

15 (1) EMPLOYMENT DATA.—Not later than 18 16 months after the date of the enactment of this Act, 17 in accordance with sections 334(a) and 634(d)(3)(A)18 of the Communications Act of 1934 (47 U.S.C. 19 334(a); 554(d)(3)(A)), the Commission, after notice 20 and comment, shall complete the proceeding initiated 21 in the Third Report and Order and Fourth Notice 22 of Proposed Rulemaking in the ongoing Review of 23 the Commission's Broadcast and Cable Equal Em-24 ployment Opportunity Rules and Policies, MM Dock-25 et No. 98-204.

1 (2) OWNERSHIP DATA.—Part I of title III of 2 the Communications Act of 1934 (47 U.S.C. 301 et 3 seq.) is amended by adding at the end the following: 4 "SEC. 344. OWNERSHIP DATA. 5 "(a) IN GENERAL.—Except as specifically provided 6 in subsection (b), the Commission may not revise— 7 "(1) section 73.3615 of title 47. Code of Fed-8 eral Regulations (relating to ownership reports), as 9 in effect on the date of the enactment of this sec-10 tion, as such section 73.3615 applies to television 11 broadcast station licensees and permittees; or 12 "(2) the forms used by the licensees and per-13 mittees described in paragraph (1) to report perti-14 nent ownership data to the Commission. 15 "(b) TECHNICAL REVISIONS OR IMPROVEMENTS.— 16 "(1) IN GENERAL.—Subject to paragraph (2), 17 the Commission may revise the regulations described 18 in subsection (a) to augment the quality and suffi-19 ciency of the reports required under such regula-20 tions, to make nonsubstantive technical or clerical 21 revisions in such regulations as necessary to reflect 22 changes in technology, terminology, or Commission 23 organization, or to ensure the anonymity of station-24 specific ownership data unnecessary to the analysis 25 of aggregated industry ownership trends.

"(2) LIMITATION.—The Commission may not
 diminish or otherwise reduce the frequency or qual ity of the reports required under the regulations de scribed in subsection (a).".

(3) Ownership and diversity report.—

6 (A) IN GENERAL.—Section 13(d)(3) of the 7 Communications Act of 1934 (47) U.S.C. 163(d)(3)) is amended by striking "in accord-8 9 ance with the national policy under section 10 257(b)" and inserting the following: "and in-11 clude in the report required by subsection (a) 12 the most recent data collected under the regula-13 tions described in sections 334(a), 344(a), and 14 634(d)(3)(A), and analysis of such data, as 15 such barriers and such data relate to the na-16 tional policy under section 257(b)".

17 (B) OWNERSHIP DATABASE.—Not later 18 than 2 years after the date of the enactment of 19 this Act, the Commission shall create a public, 20 searchable database of the data collected under 21 the regulations described in section 344(a) of 22 the Communications Act of 1934, as added by 23 paragraph (2), that members of the public may 24 use to search for and produce reports identi-25 fving5
