## SUBCOMMITTEE ON CONSUMER PROTECTION AND COMMERCE VIRTUAL MARKUP

## **THURSDAY, May 27, 2021**

The Subcommittee on Consumer Protection and Commerce of the Committee on Energy and Commerce met, pursuant to notice, at 11:08 a.m., a quorum being present, for a virtual markup on the Committee's WebEx platform, Hon. Jan Schakowsky (Chair of the subcommittee) presiding. The business before the Subcommittee was consideration and markup of H.R. 2668. The following actions were taken:

**1. H.R. 2668**, the "Consumer Protection and Recovery Act", was ordered reported favorably to the full Committee, **amended**, by a voice vote. (**Final Passage**).

- **A motion to table the motion to postpone indefinitely**, offered by Mr. Pallone, was agreed to by a roll call vote: 13-7 (*CPC Roll call no. 02*).

The following amendments were offered during consideration of H.R. 2668:

- An Amendment in the nature of a substitute (AINS) #1 (H2668\_ANS\_02), offered by Mr. Cárdenas, was agreed to by a voice vote.
- Amendment to the Cárdenas AINS #1a (LIMITATIONS\_5\_01), offered by Mr. Bilirakis, was withdrawn.
- Amendment to the Cárdenas AINS #1b (DISGORGE\_2003\_01), offered by Mr. Armstrong, was defeated by a roll call vote: 7-14 (CPC Roll call no. 03).
