We write to expand a request for your offices to investigate the potentially illegal submission of fake comments to federal regulatory agencies. In June, the Federal Bureau of Investigations (FBI) and the Department of Justice (DOJ) were requested to conduct an investigation of whether the submission of fraudulent comments to the Federal Communications Commission (FCC) using stolen identities violated federal law. Since June, it has come to our attention that other regulatory agencies are also facing a scourge of fake comments that may similarly violate the law.

The fraud perpetrated in the FCC's rulemaking appears to directly violate federal law. As more details have come to light, the scope of that fraud becomes more alarming. The FCC's proceeding to roll back consumers' net neutrality protections was irreparably tainted by millions of fake comments using email addresses of real people who had nothing to do with those comments.³

It now appears that the fake comments submitted to the FCC's rulemaking to roll back consumers' net neutrality protections were not an isolated incident. At least five agencies have been the target of falsely generated rulemaking comments. In addition to the FCC, the Consumer Financial Protection Bureau (CFPB), the Federal Energy Regulatory Commission, the Securities and Exchange Commission, and most recently, the Department of Labor have all been affected.⁴

In the case of the CFPB, false comments opposing new regulations to protect consumers from unscrupulous payday lending practices were reportedly submitted under the names of victims of such practices. An analysis conducted for the *Wall Street Journal* revealed that a significant portion of the fake comments filed in the CFPB's payday-lending rule originated from a comment-generating platform and web address used by the Community Financial Services Association of America (CFSA), a trade group representing payday lenders. The CFSA, however, denies awareness of how the fake claims came to be filed through its website "TelltheCFPB.com."

The practice of manipulating agency actions by flooding rulemaking dockets with fake comments is far more widespread than it appeared when you were initially asked to investigate. Some Americans' voices are being co-opted in what appears to be a systemic attempt to corrupt federal policy-making.

Immediate action is needed in order to restore public trust in the federal rulemaking process. We urge you to use the full investigative powers of the FBI and DOJ to promptly uncover who is behind this conduct and prosecute the parties under applicable federal law.
