- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Ensuring Phone and
- 5 Internet Access Through Lifeline and Affordable
- 6 Connectivity Program Act of 2022".

1	SEC. 2. REPORTS ON ENROLLMENT IN CERTAIN PRO-
2	GRAMS.
3	(a) Annual Report on Enrollment in Lifeline
4	AND AFFORDABLE CONNECTIVITY PROGRAMS THROUGH
5	QUALIFYING PROGRAMS.—Not later than 1 year after the
6	date of the enactment of this Act, and annually thereafter
7	for 2 calendar years after the calendar year during which
8	the first report is submitted under this subsection, the
9	Commission shall submit to Congress a report on—
10	(1) enrollment in the Lifeline program by indi-
11	viduals participating in each of the Lifeline quali-
12	fying programs, broken out by each of the Lifeline
13	qualifying programs, to the extent the Commission
14	holds or has access to the necessary data relating to
15	such enrollment; and
16	(2) enrollment in the Affordable Connectivity
17	Program by individuals participating in each of the
18	Affordable Connectivity Program qualifying pro-
19	grams, broken out by each of the Affordable
20	Connectivity Program qualifying programs, to the
21	extent the Commission holds or has access to the
22	necessary data relating to such enrollment.
23	(b) GAO STUDY AND REPORT ON EFFORTS TO PRO-
24	MOTE ENROLLMENT IN LIFELINE AND AFFORDABLE
25	CONNECTIVITY PROGRAMS.—Not later than 1 year after
26	the date of the enactment of this Act, the Comptroller
