Syracuse Police Department: Approach to Synthetic Drugs (SPIKE) Problem

Beginning in 2013 the Syracuse Police Department (SPD) responded to an increase in use and subsequent overdoses of synthetic marijuana (spike). SPD implemented various means of tracking the problem in addition to the police response to it. In 2015 Syracuse saw the largest number of overdoses from use of synthetic marijuana; the largest number of overall calls for service, calls for service related to overall overdoses and persons down; and also made the largest number of arrests related to the substance. Specific actions taken by SPD as well as measurements of the problem are listed below, and supporting documents are attached.

Spike Overdose Report

-In 2013 SPD created the Overdose Report (Form 13.9) to track spike-related overdoses in the RMS. In September 2014 this report was discontinued after a more efficient process was created.

Court Information

-In April 2014 SPD circulated the Court Information for NYS Public Health Law 229.00 Sanitary Code Violation as well as a DEA publication to inform Officers of existing knowledge regarding spike.



Local Law Ticket

-In July 2014 SPD created an arrest appearance ticket (simplified court information) for synthetic drugs to aid in documentation and the ability of Officers to make arrests.

-Overall, from 2014 to 2017 there were 1436 arrests for this charge



HIDTA Intelligence Report

In April 2015 an Intelligence Report was drafted by a local HIDTA representative regarding the recent increase in spike overdoses. Information from NYS Poison Control indicated there were 30 overdoses in two days. A possible source of dangerous spike was identified and a bulletin was released to local law enforcement.





Tracking Overdoses


-In April 2015 SPD and the Onondaga Crime Analysis Center (OCAC) created a database to track all overdoses that were reported to the police. The data includes spike and other drug overdoses, and is maintained currently by a HIDTA Analyst at OCAC. The highest amount of spike overdoses occurred in the summer of 2015.






Tracking Police Response to Overdoses

-SPD and the Onondaga Crime Analysis Center (OCAC) track police reports of overdoses and persons down based on calls for service data. The data includes all types of overdoses and reasons for a person down. The peak in the number of related calls coincides with the peak in reported overdoses of spike overall. There was also a peak in calls for service of all types during the same time frame.
