## A BILL

To amend title XVIII of the Social Security Act to ensure equitable payment for, and preserve Medicare beneficiary access to, diagnostic radiopharmaceuticals under the Medicare hospital outpatient prospective payment system.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

**1 SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Facilitating Innovative  
3 Nuclear Diagnostics Act of 2023”.

**4 SEC. 2. SEPARATE PAYMENT FOR CERTAIN DIAGNOSTIC  
5 RADIOPHARMACEUTICALS.**

6 (a) IN GENERAL.—Section 1833(t)(16) of the Social  
7 Security Act (42 U.S.C. 1395(t)(16)) is amended by add-  
8 ing at the end the following new subparagraph:

9                   **“(H) SEPARATE PAYMENT FOR CERTAIN  
10 DIAGNOSTIC RADIOPHARMACEUTICALS.—**

11                   “(i) IN GENERAL.—Notwithstanding  
12 any other provision of this subsection, with  
13 respect to services furnished on or after  
14 January 1, 2024, the Secretary shall not  
15 package, and shall make a separate pay-  
16 ment as specified in clause (ii) for a diag-  
17 nóstic radiopharmaceutical (as defined in  
18 clause (v)) with an estimated mean per day  
19 product cost equal to or exceeding the  
20 threshold specified in clause (iii).

21                   “(ii) SEPARATE PAYMENT.—For pur-  
22 poses of clause (i), the separate payment  
23 specified in this subclause for a diagnostic  
24 radiopharmaceutical described in clause (i)  
25 shall be equal to—

1                         “(I) the average sales price for  
2                         the drug established under section  
3                         1847A, to the extent the average sales  
4                         price is available, as calculated and  
5                         adjusted by the Secretary to the ex-  
6                         tent such adjustment is adopted for  
7                         other specified covered outpatient  
8                         drugs under paragraph (14)(A); or  
9                         “(II) if the data necessary to cal-  
10                         culate the average sales price for the  
11                         drug in the year under the section  
12                         and paragraph specified in subclause  
13                         (I) is not available, the wholesale ac-  
14                         quisition cost (as defined in subsection  
15                         1847A(c)(6)(B)), as calculated and  
16                         adjusted by the Secretary to the ex-  
17                         tent such adjustment is adopted for  
18                         other specified covered outpatient  
19                         drugs under paragraph (14)(A), or, if  
20                         the wholesale acquisition cost is not  
21                         available, the mean unit cost data de-  
22                         rived from hospital claims data.  
23                         Nothing in this subparagraph shall be con-  
24                         strued as affecting eligibility of diagnostic

1                   radiopharmaceuticals for pass-through pay-  
2                   ments under paragraph (6).

3                   “(iii) THRESHOLD.—For purposes of  
4                   this subparagraph, the threshold specified  
5                   in this clause—

6                   “(I) for 2024, is \$500; and

7                   “(II) for a subsequent year, is  
8                   the amount specified in this clause for  
9                   the preceding year increased by the  
10                  OPD fee schedule increase factor  
11                  under paragraph (3)(C)(iv) for the  
12                  year.

13                  “(iv) BUDGET NEUTRALITY.—The  
14                  Secretary shall make such adjustments as  
15                  are necessary under paragraph (9)(B) to  
16                  ensure that the amount of expenditures  
17                  under this subsection for a year with appli-  
18                  cation of this subparagraph is equal to the  
19                  amount of expenditures that would be  
20                  made under this subsection for such year  
21                  without application of this subparagraph.

22                  “(v) DEFINITION OF DIAGNOSTIC  
23                  RADIOPHARMACEUTICAL.—For purposes of  
24                  this subparagraph, the term ‘diagnostic  
25                  radiopharmaceutical’ means a drug or bio-

1                   logical that is described in section 315.2(a)  
2                   of title 21, Code of Federal Regulations, or  
3                   any successor regulation, and is approved  
4                   by the Food and Drug Administration on  
5                   or after January 1, 2008.”.

6         (b)    NO    IMPACT    ON    COPAYMENT.—Section  
7    1833(t)(8)(E)    of the Social Security Act (42 U.S.C.  
8    1395l(t)(8)(E)) is amended—

9                   (1) in the heading, by inserting “AND SEPA-  
10          RATE PAYMENTS FOR CERTAIN DIAGNOSTIC RADIO-  
11          PHARMACEUTICALS” after “PASS-THROUGH ADJUST-  
12          MENTS”; and

13                   (2) by inserting “and paragraph (16)(H)” after  
14          “such adjustments”).
